2.3 The confirmation of receipt of the order follows immediately after sending the order. The sales agreement is reached but only with our delivery confirmation or delivery of the goods. .

3 prices, delivery and payment arrangements

3.1 All prices quoted are inclusive of the date of execution performance valid VAT.

3.2 Delivery shall be made with the shipping that you specify in your order shipping address. The expected delivery time specified in the respective product. This information is not binding unless otherwise agreed. If goods are not in stock, we will order the goods without delay, inform the customer about it and say that the expected delivery date. For various reasons (delivery problems, set production, poor quality, etc.), products of your order to process your purchase not be available. In this case, we attach a replacement item. Are products of involuntary way are not available, you will be informed immediately, and might already provided compensation reimbursed.

3.3 The payment of the goods either by Moneybookers, Paypal, COD, advance payment or by Sofortüberweisung (only Germany, Austria, Switzerland, Netherlands, Belgium, United Kingdom).

3.4 Moneybookers: Payments will be posted immediately and the dispatch of your order will be immediately passed to the dispatch center ships.

3.5 PayPal: Payments via PayPal will be posted immediately and the dispatch of your order will be initiated immediately and resulted in the dispatch center.

4 partial shipments

We are entitled to partial deliveries as far as is reasonable for you. Additional shipping costs unless otherwise expressly agreed.

5 return costs

Where the consumer of his right under paragraph 6 of the Conditions of use, so he has to bear the normal costs of returning the goods if the delivered goods ordered and if the price returned the case of an amount of 40.00 € exceeds or has not yet rendered at a higher price to the cause of consumers in return or a contractually agreed partial payment at the time of the revocation.

6 Withdrawal

Revocation / Cancellation

The time limit begins after receipt of this notification in writing, but not before receipt of goods by the recipient (the recurring supply of similar goods not before receipt of the first partial delivery) and also does not fulfill our Information according to Article 246 § 2 in connection with § 1 para 1 and two draft Law and our obligations according to § 312e paragraph 1 sentence 1 BGB in Conjunction with Article 246 § 3 EGBGB. Consequences

In the event of a cancellation the mutually received Services to be returned and possibly towed uses (such as Interest). Can you give us the performance received whole or partially or only in deteriorated condition , To return you must pay us compensation for the value. In Release of things this does not apply if the deterioration of Case solely on their exam - as you in Shop would have been possible - is due. Moreover, to the obligation to pay compensation for the intended use the item Avoid degradation by using the goods as your property take and use anything that could reduce its value.

Package are to be returned at our risk.
